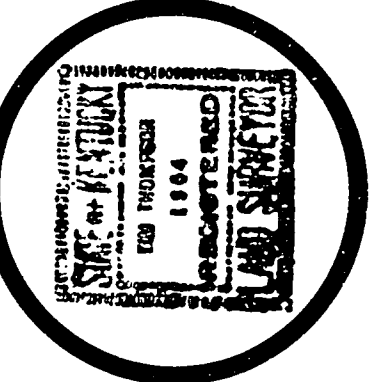
VIGNETTY MAP
